THE SECOND ANNUAL MIKE'S CHICAGO DOG HOT DOG EATING CONTEST

On Saturday, August 4, 2018 as part of the All American City of Asheboro/Randolph County Chamber of Commerce Pigs and Pedals weekend, Mike's Chicago Dog will host two Hot Dog eating competitions. The first event will be a female competition at 10:30 AM, followed by a men's competition at 10:45 AM. The entry fee is \$10. Price money will be awarded. Amounts will be determined based on the number of entrants.

Contest Rules

1. Each competition will be limited to 15 competitors. The 15 contestants will be the first 15 females and first 15 males to submit an application with all relevant information as well as a signed waiver and the \$10 entry fee to Mike or one of his associates, at the restaurant, by of before August 3, 2018.
2. Competitors must be at least 18 years of age.
3. Competitors for both competitions must check-in with ID to Mike or one of his associates by 10:00 AM on August 4, 2018. Failure to check in by 10:00 AM will result in disqualification and a forfeiture of the entry fee.
4. The competition will last for 5 minutes. The objective is to eat as many Hot Dogs and Buns as possible within the allotted 5 minute timeframe with water being the only beverage used to assist swallowing.
5. Each contestant will be given 10 Hot Dogs in Buns to start. More will be provided, if necessary.
6. Each contestant will not touch their Hot Dogs until given the official start of the competition.
7. Dunking and crunching the Dog/Bun is allowed.
8. Separating the Dog and Bun to be eaten separately is allowed.
9. There will be one judge for every three competitors. Once a competitor has swallowed each Hot Dog and Bun, the competitor is to slam their hand on the eating table as a signal to their judge that they are advancing to the next Hot Dog and Bun.
10. Any sign of physical sickness will result in disqualification.
11. Only fully consumed Hot Dogs and Buns that are fully swallowed will be counted.
12. At the end of five minutes, competitors with a partially eaten Hot Dog and Bun in their mouth that has not been swallowed will be given twenty additional seconds to swallow. Any Hot Dog and Bun not swallowed will not be counted.
13. Mike's Chicago Dog judges will determine the winner of the contest and the decision of the judges will be final.
14. Any contestant caught breaking any of the above rules will be disqualified.
15. In the event of a tie, an eat-off will take place with each competitor given 5 Hot Dogs with a 3 minute clock.
16. Local newspaper and television coverage is likely. As a competitor, you must be willing to potentially be interviewed and/or filmed for broadcast.
